Stalls and paddocks will be reserved upon receipt of ride application.

Camping will be in the West Lot area of Shaker Village. Primitive camping, no electrical hookups. Horse water will be available. All vet checks will be at the camp site in the West Lot. Vetting of horses will begin on Friday at 3 o'clock p.m. until dark. Please make every effort to arrive at Shaker Village before dark on Friday. You must cross a narrow bridge located at a turn in the road, and it is much easier to cross during daylight than at night. Ride management suggests you arrive in sufficient time to vet in your horse and to attend the ride meeting which will be at approximately 6:15 p.m.

The trails will be primarily through rolling hills in open pasture, and will border historic rock fences. There will be a few creek crossings with plenty of rocks. However, pads are not recommended.

Shaker Village has reserved a number of rooms in the West Lot Lodge and Wash House for the ride. If you want to reserve a room, please call Ann Voris at Shaker Village 1-800-734-5611, extension 1548. For information about Shaker Village see its web site shakervillageky.org.

If you plan to arrive on Thursday, November 15, 2011, please call Don Pelly (1-800-734-5611, or 859-325-0408) so he can make camping arrangements for you. Early arrival fee of \$10.00 must be paid to Shaker Village. You can pay this fee upon check in.

CANCELLATION OF RIDE

In the event of extreme temperatures, freezing rain, or a severe snowstorm, you will be notified on Thursday, November 15, 2012, that the ride has been canceled

Shaker Village is located at the caution light on U.S. 68, at the intersection of KY Route 33. The entrance to Shaker Village is six miles east of the intersection of U.S. 127, Harrodsburg bypass and U.S. 68. It is not recommended that you take U.S. 68 from Lexington to Shaker Village due to the tight turns going down to the Kentucky River.

After turning into Shaker Village, turn left at the guard house, drive past the pond and keep driving on the blacktop road to the West Lot, about a 1 mile.

KRS 247.4027: Under Kentucky law, a farm animal activity sponsor, farm animal professional, or other person does not have the duty to eliminate all risks of injury of participation in farm animal activities. There are inherent risks of injury that you voluntarily accept if you participate in farm animal activities.

I wish to enter and participate in the Kentucky Diehards Endurance Ride to be held at Shaker Village at Pleasant Hill, 3501 Lexington Road, Harrodsburg, Kentucky. The dates I may participate are November 16, 2012 through November 18, 2012. As a participant in the Kentucky Diehards endurance ride, I agree to abide by the rules of AERC, OAATS, SERA, and ride management. I understand that endurance riding involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; that these areas have many natural and man-made hazards, which ride management, cannot anticipate, identify, modify or eliminate; that horses (equines) are excitable, difficult to control and unpredictable; that accidents can happen to anyone at any time. I agree to take full responsibility for myself and the equine I am riding/handling. I will hold ride manager Jim Rogan, ride management, all ride personnel and volunteers, all veterinarians and Shaker Village of Pleasant Hill, Harrodsburg, Kentucky, and all property owners over whose land the ride crosses blameless for any accident, injury or loss that might occur due to my participating in the ride, and free from all liability for such injury or loss. This release extends to all claims of every kind and nature whatsoever, whether known or unknown, and I expressly waive any benefits that I may otherwise have under provisions of the laws of the Commonwealth of Kentucky relating to the release of unknown claims.
